# Authorized Public Trust 'MOL Mauritius International Fund for Natural Environment Recovery and Sustainability' Selects 1<sup>st</sup> Year Grant Recipient Projects and Starts Grant Payment ~ Recovery and Sustainability of Environment and Local Communities Contribution Activities in Mauritius ~

TOKYO—Mitsui O.S.K. Line, Ltd. (MOL; President & CEO: Takeshi Hashimoto) today announced that its authorized public trust, the "MOL Mauritius International Fund for Natural Environment Recovery and Sustainability" (Note 1) has selected grant recipient projects for its first year (Chart 1) at the first steering committee meeting in March 2022, and started funding grants at the end of April. The fund was established in November 2021 as a part of MOL's aid activities to promote the recovery and sustainability of the environment and communities in the Republic of Mauritius.

Organizations in Mauritius and research institutes and organizations in Japan applied for first-year funds for many high-quality projects. After a fair and objective evaluation by the fund steering committee, a total of 11 projects in two categories— "natural environment restoration and conservation projects" and "local community contribution projects." The total grant amount is about ¥100 million.

## (Chart 1) Outlines of selected projects

\*In the case of a US dollar grant, the yen exchange rate is applied at the exchange rate of the remittance date. The above grant amounts are approximate amounts calculated by applying the current exchange rates.

The fund selects longer-term and larger-scale projects in comparison to the "MOL Charitable Trust" (Note 2) established in Mauritius in June 2021, and plans with a term up to five years depending on the project <sup>(Chart 2)</sup>. It supports the development of fisheries, tourism, and cultural activities, which are the foundation of the Mauritian economy, as well as recovery and preservation of its natural environment and diverse ecosystems such as mangrove forests and coral reefs, and research and protection efforts related to wild and migratory birds including endemic species.

The MOL Group specifies "local community contribution activities in Mauritius" in its action plan on the theme of "regional development" in the "MOL Sustainability Plan" (Note 3). It makes concerted group-wide efforts to continue its activities with people in Mauritius so that its support can broadly be distributed to the nation and its citizens.
