## **MOL Announces Restructuring Measures and Renaming of Position Title**

TOKYO—Mitsui O.S.K. Lines, Ltd. (MOL; President & CEO: Takeshi Hashimoto) today announced that it will implement a series of restructuring measures and renaming position title effective April 1st.

### **1. Restructuring and renaming of Corporate Organization**

Corporate Organization will be restructured and renamed as follows. The underlined parts are the changes associated with this restructuring and renaming, and the details of each individual change are described below.

#### **(1) Establishment of Investor Relations Division**

The "Investor Relations Division" will be newly established and be responsible for all investor relations activities.

#### **(2) Restructuring and renaming of Headquarters of Safety & Quality Enhancement**

- The "Headquarters of Safety Operations" will be renamed to the "Headquarters of Safety & Quality Enhancement" which will serve as the organization responsible for ensuring safety and improving quality across the MOL Group.
- The "Marine Safety Division," the "Ship Management Strategy and Supervising Division (Dry Cargo)," and the "Ship Management Strategy and Supervising Division (Energy)" will be restructured under the "Marine & Marine Technical Group." "The Marine & Marine Technical Group" will be formed of the "Marine Unit," responsible for risk management and formulation of strategy for ensuring safety and improving quality across the MOL Group, primarily related to MOL-operated vessels; the "Marine Technical Unit," responsible for supporting business activities through diverse marine transport expertise; and the "Business Coordination Unit," responsible for all shipowner-related operations.

- MOL Global Ship Management Pte. Ltd., responsible for the MOL Group's ship management functions, will be newly added to this headquarters.

(3) Restructuring of Headquarters of Technological & Digital Transformation

- The IT governance promotion responsibilities will be transferred to the "DX Co-Creation Unit," responsible for formulation of the MOL Group's digital transformation strategy, and the "DX Co-Creation Unit" will be renamed to the "IT & Digital Strategy Unit."
- The "Liquefied Gas Technical Unit" and the "Offshore Technical Unit," under the "Headquarters of Technological & Digital Transformation," will be transferred to the "Headquarters of Energy Business, LNG & Ethane Business Group" and the "Headquarters of Energy Business, Wind Power and Offshore Business Group" respectively.

(1) Restructuring and renaming of Headquarters of Dry Bulk Business

The "Iron and Steel Business Division," the "Steaming Coal Business Division," and MOL Ocean Bulk Pte. Ltd. will be restructured under the "Bulk Resources Business Group." The "Iron and Steel Business Division" will be renamed to the "Iron and Steel Unit," and the "Steaming Coal Business Division" will be renamed to the "Steaming Coal Unit."

(2) Restructuring of Headquarters of Energy Business

The "Carbon Solution Business Group, Tanker Unit 1" and "Carbon Solution Business Group, Tanker Unit 2" will be restructured as the "Carbon Solution Business Group, Tanker Unit."

(3) Establishment of Headquarters of Chemical Logistics Business
