2. Types of Personal Data Processed

The items described in Chapter 2, "Types of Personal Data Processed," of the MOL Group Global Privacy Policy include information that falls under sensitive personal information (Biometric information, medical and health information, financial account information, etc.) under Chinese law. Sensitive personal information collected from you is processed for the purposes of Chapter 3, "Legal Basis and Purpose of Personal Data Processing," of the MOL Group Global Privacy Policy.

When processing your sensitive personal information, our group will ensure appropriate security by taking the measures described in Chapter 7, "Security Measures" of the MOL Group Global Privacy Policy in order to store and manage your personal data in an accurate and up-to-date state and to prevent leakage, etc.

4. Transfer of Personal Data

Our group may disclose or/and provide your personal data to the third parties described in Chapter 4, "Transfer of Personal Data," of the MOL Group Global Privacy Policy. For the contact information of the third parties, please contact the contact point described in Chapter 10, "Procedures and Contact Points for Exercising Rights" of the MOL Group Global Privacy Policy.

If our group discloses or/and provide your personal data to a third party, our group will notify you and obtain your explicit consent in accordance with the requirements of laws and regulations.

5. International Transfer of Personal Data

Our group may transfer personal data collected from you to the third parties described in Chapter 4, "Transfer of Personal Data," of the MOL Group Global Privacy Policy that are located in a different country/region from where you reside (hereinafter referred to as "international transfer") to process it. For the contact information of the third parties, please contact the contact point described in Chapter 10, "Procedures and Contact Points for Exercising Rights" of the MOL Group Global Privacy Policy.

When our group conducts international transfer of your personal data, our group will appropriately protect your personal data by obtaining your explicit consent, preparing a report on personal information protection impact assessment, and implementing necessary measures based on the assessment results, in accordance with the requirements of laws and regulations.

In addition, except in certain cases*, our group will take the following safeguard:

 Conclusion of a Standard Contract for the Cross-border Transfer of Personal Information with the recipient: Our group will conclude a Standard Contract for the Cross-border Transfer of Personal Information with the recipient to ensure that the recipient has the same level of personal data protection as our group.

- where it is necessary to provide personal data overseas in order to conclude or perform a contract to which you are a party, such as cross-border shopping, cross-border delivery, flight and hotel reservation, visa processing, etc.
- where it is necessary to provide employees' personal data overseas as part of implementing crossborder human resources management in accordance with employment rules and labor agreements formulated in accordance with the law
- where our group is not a critical information infrastructure operators and the total amount of personal data that has been provided overseas since January 1 of the relevant year is less than 100,000 (and it does not include sensitive personal information)
- where data is such data collected and generated in international trade, academic cooperation, crossborder production and marketing, etc. that do not contain personal data or important data
- where personal data collected and generated overseas is transmitted to the territory for processing and then provided overseas, and no domestic personal data or important data is introduced during the processing
- where, in an emergency, it is necessary to provide personal data overseas in order to protect the life, health, or property safety of a natural person

9. Your Rights

With respect to personal data processed by our group, you have the following rights:

- · Right to be informed about and make decisions regarding the processing of your personal data
- · Right to restrict or refuse the processing of your personal data by any third parties
- · Right to gain access to or obtain copies of your personal data held by our group
- · Right to request the transfer of your personal data to a designated third party, provided that the transfer meets the conditions stipulated by the National Network Division
- Right to request the rectification or supplementation of any inaccuracy or incompleteness in your personal data
- · Right to request the deletion of your personal data under certain circumstances
- · Right to seek interpretation or clarification of the regulations governing the processing of your personal data at our group
- · Right to seek clarification on automated decisions and the right to reject decisions that rely solely on automated decisions
